**1. POLICY:** The Federal Law Enforcement Training Center (FLETC) provides health screening and treatment services to students, FLETC staff, and Partner Organization (PO) staff to maintain optimal health while training or on the job. The FLETC ensures that health treatment and screening services are distributed in a fair and equitable manner.

**2. SCOPE:** This directive applies to students, FLETC staff, and PO staff of the FLETC at Glynco, Georgia; Artesia, New Mexico; and Charleston, South Carolina. The facility at Cheltenham does not have a Health Unit; therefore information concerning specific health unit services does not apply to the Cheltenham facility. Further, this directive does not apply to non-Government, FLETC visitors, contractors, and individuals under 18 years of age. However, emergency medical care may be provided as appropriate, to include individuals under 18 years of age without parental consent.
