**1. POLICY:** It is the policy of the Federal Law Enforcement Training Center (FLETC) to manage all aspects of FLETC operations in an environmentally sustainable manner. As such, we utilize an environmental management system modeled on the guidance contained in International Organization for Standards 14001.

**2. SCOPE:** This directive applies to all FLETC locations and training sites and contains elements that apply to all FLETC staff, Partner Organization representatives and staff, students, guests, and contractor personnel.
